7NEWS Coles Competition
Terms and Conditions**

**By entering “7NEWS Coles Competition”
 (“the Competition”), you are agreeing to the following Terms and Conditions:**

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms and conditions (“**Terms and Conditions**”). Participation in this Competition is deemed acceptance of these Terms and Conditions.

2. WHO CAN ENTER?

2.1 Subject to clause 2.2, entry is open to all residents of NSW, ACT, SA, WA, QLD and VIC, aged 18 years and above, where the Channel Seven (and affiliates) signal is received.

2.2 Employees and their immediate friends and families of the Seven Network (Operations) Limited, Coles Supermarkets Australia Pty Ltd, Ansible Pty Ltd, and their associated agencies and companies are not eligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

3. HOW TO ENTER

3.1 The Competition commences on **Monday 27th June 2022 at 18:00 AEST** and concludes on **Friday 8th July at 23:59 AEST** (“the **Competition Period**”).

3.2 To enter, viewers must watch 7NEWS (“the **Program**”) on the Seven Network (“the **Network**”), throughout the Competition Period. There will be one competition segment aired during the weekday episodes of the Program during the Competition Period, which will display information on how to enter the Competition and the valid codewords for that registration period. There will be one (1) codeword advertised per registration period. Each entrant must enter into the Competition with the codeword that is valid within the corresponding registration period.

3.3 In order to enter the Competition, viewers must head to www.7news.com.au/giftcard and register all required details including a valid codeword for that registration period and the entrant’s full name, suburb and state (“**Valid Entry**”).

- 3.5 For clarification, all entrants who enter during the Competition Period will be entered into the Major Prize Draw corresponding with the registration period in which they entered.
- 3.6 Entries do not carry over between registration periods. Entrants must submit an entry within a registration period, stipulated in the table in clause 3.4, with a valid codeword during that period to be in the running for the corresponding Major Prize Draw.

Total maximum prize pool value for the prizes is up to **\$250,000.00** (including GST).

Maximum prize pool per state group (NSW/ACT, SA, QLD, VIC and WA) is **\$50,000.00** (including GST).

- 4.3 In accepting a prize, the winner agrees to participate in and co-operate with all reasonable media editorial requests, including but not limited to, being interviewed and photographed, and the winner grants the Promoter a perpetual and non-exclusive licence to use such footage and photographs in all media worldwide and the winner will not be entitled to any fee for such use.

- 4.8 The Major Prize Winners will be selected at random by Ansible Pty Ltd and contacted directly by a member of the Ansible Pty Ltd team via email and phone call within two (2) business days of the relevant draw. The Major Prize Winners' names and suburbs will be published on the 7NEWS website within five (5) business days of the relevant prize draw and during the 7NEWS broadcast on the date stipulated in clause 3.4.
- 4.9 Major Prize Winners may be required to provide valid identification to Ansible Pty Ltd to prove they meet the valid entry requirements.
- 4.10 In the event that an element of a prize outlined in the above is not available for any reason, the Promoter reserves the right to substitute with a similar product of equal or greater value, subject to state regulations.

- 5.3 The first valid entry drawn in each Major Prize Draw will win a Major Prize, detailed in clause 4.2.
- 5.4 This is a game of chance and skill plays no part in determining the winners.
- 5.5 Entries that do not comply with any of the Terms and Conditions, may be deemed invalid in which case the Promoter will revert to a reserve entry drawn (if reserve entries are drawn) or a redraw will take place.
- 5.6 In the event that a codeword does not go to air for any reason including, but not limited to, breaking news and/or changes to live television, a prize draw will be conducted at the end of the competition period from all entries received throughout the competition period in order to allocate the corresponding prize to a valid winner.
- 5.7 Major Prize Winners will be notified by a phone call and in writing by e-mail from a member of Ansible Pty Ltd within two (2) business days of the each Major Prize Draw. Winners names will be published on the 7NEWS.com.au website within five (5) business days of each Major Prize Draw and on air during 7NEWS on the date stipulated in clause 3.4.
- 5.8 The Promoter's decision is final and the Promoter will not enter into correspondence regarding the result.
- 5.9 The Promoter and/or Ansible Pty Ltd may in its absolute discretion deem entries invalid subsequently to a winner being notified or a winner's name being announced if it is discovered that the winner did not enter the Competition in accordance with these Terms and Conditions. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
- 6.2 Incomplete or indecipherable entries will be deemed invalid.

- 7.2 Seven Network (Operations) Limited, Ansible Pty Ltd, Coles Supermarkets Australia Pty Ltd and their associated agencies and companies will take no responsibility for prizes damaged or lost in transit, or late, lost or misdirected mail.
- 7.3 Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia. Except for any liability that cannot by law be excluded, Seven Network (Operations) Limited, Ansible Pty Ltd, Coles Supermarkets Australia Pty Ltd and their associated agencies and companies will not be liable for any misadventure, accident, injury, loss (including but not limited to consequential loss) or claim that may occur:

 - d) due to the broadcast of any program relating to the Competition or the publication of any material, including any statements made by any compere, staff member, journalist, other entrants or any other person; or

available, and to cancel, terminate, modify or suspend the Competition, subject to state government legislation.
