Terms and Conditions

By entering “7NEWS Perth Freo Final Box Seats Promotion” (“the Competition”), you are agreeing to the following Terms and Conditions:

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

- 2.1 Subject to clause 2.2, entry is open to all residents of Perth aged 18 years of age or older, where the Channel Seven (and affiliates) Perth signal is received.
- 2.2 Employees and their immediate friends and families of the Seven Network (Operations) Limited (“the Promoter”), McDonald's Australia Limited (“the Sponsor”), Ansible Pty Ltd, and their associated agencies and companies are not eligible to enter.
- 2.3 Major and Minor Prize Winners must be available to attend the prize event at Optus Stadium on Saturday 3rd September 2022. If a winner is unable to attend, they will be deemed invalid, forfeit the prize in its entirety and a re-draw will take place.

3. HOW TO ENTER

3.1 The Competition commences **Sunday 28 August 2022 at 18:00 AWST** and concludes on **Wednesday 31 August 2022 at 23:59 AWST** (“the Competition Period”). Daily eligible registration periods will commence and conclude on the following dates (“Registration Period”):

3.2 For entry details, viewers must watch 7NEWS Perth on the Seven Network (“the Network”) during the Competition Period from **Sunday 28 August 2022 at 18:00 AWST to Wednesday 31 August 2022 at 23:59 AWST** (“the Program”). There will be a competition segment aired during the Program (or any replacement program broadcast in the 7NEWS timeslot) from Sunday to Wednesday in the competition period, which will display information on how to enter.

3.3 A new codeword will be available in the 6.00pm 7NEWS bulletin each night during the competition period. A total of 4 codewords will be available throughout the competition period.

3.5 **COMPETITION ENTRY:** In order to enter the Competition, viewers must:
