7NEWS Sydney x Sydney Zoo Competition  
Terms and Conditions

By entering “7NEWS Sydney x Sydney Zoo Competition” (“the Competition”), you are agreeing to the following Terms and Conditions:

**1. STANDARD TERMS**

1.1 Information on how to enter forms part of the terms of entry.

**2. WHO CAN ENTER?**

2.1 Subject to clause 2.2, entry is only open to all residents of Sydney aged 18 years of age or older, where the Channel Seven (and affiliates) Sydney signal is received.

2.2 Employees and their Immediate Family Members of the Seven Network (Operations) Limited (“the Promoter”, “Seven”), Prime Television (Holdings) Pty Limited, West Australia Newspapers Limited, Sydney Zoo Pty Ltd (“the Sponsor”), Ansible Pty Ltd, and their associated agencies and companies are not eligible to enter.

2.3 In this clause 2 “Immediate Family Members’ includes a spouse, defector spouse, parent, natural or adopted child or sibling.

**3. HOW TO ENTER**

3.1 The Competition commences **Monday 19 September 2022 at 16:00 AEST** and concludes on **Friday 23 September 2022 at 19:00 AEST** (“the Competition Period”).

3.2 For entry details, viewers must stream 7NEWS (“the Program”) on 7plus via connected TV, desktop, mobile or tablet during the Competition Period from **Monday 19 September 2022 at 16:00 AEST** to **Friday 23 September 2022 at 19:00 AEST** and look out for the promotion that includes the competition codeword (“Codeword”) and information on how to enter. The Codeword will be displayed randomly during some Program streams Monday to Friday between 16:00 AEST and 18:00 AEST during the Competition Period.

3.3 The Codeword may appear anytime between 4.00pm and 7.00pm each weeknight during the 7NEWS live stream on 7plus during the Competition Period. There will be one Codeword available throughout the entire Competition Period.

3.5 **COMPETITION ENTRY:** In order to enter the Competition, viewers must:

- Head to [7NEWS.com.au/sydneyzoo](https://7NEWS.com.au/sydneyzoo); and
- Complete all required fields including the valid Codeword in the competition entry form

3.6 Entries are limited to one (1) entry per person per day throughout the Competition Period. Entrants are only eligible to win one (1) prize.

3.7 For an entry to be considered valid, the entrant must enter the required details and specify the correct Codeword when entering. If the Codeword is incorrect, it will render the entry invalid.

**4. PRIZES**

4.1 There will be Fifty (50) prize winners (“Winners”) randomly drawn from all valid entries who will each receive the following Prize as detailed in clause 4.2

Total maximum prize pool value for the prize is **\$6,748.00** (including GST). Prize value is correct as at the date of printing. The Promoter accepts no responsibility for change in prize value between now and the ultimate date on which the prize is taken.

- 4.3 Sydney Zoo Family Passes are valid for eighty-nine (89) days from the date the link to redeem the tickets is sent to the Winners. Prize must be used during this period and all tickets included in the Prize must be used together.
- 4.4 Sydney Zoo Family Passes will be provided to Winners in the form of a unique code sent by email within five (5) business days of Winner being drawn. It is the responsibility of the Winners to check their email and junk folders for this detail, and to redeem their unique code for their Family Pass online at <https://sydneyzoo.com/tickets> Sydney Zoo checkout within eighty nine (89) days of the link being sent to Winners. Tickets are valid for use for eight nine (89) days of the link being sent via email to Winners by Ansible Pty Limited.
- 4.5 In accepting a Prize, the Winners agrees to participate in and co-operate with all reasonable media editorial requests, including but not limited to, being interviewed and photographed, and the winner grants the Promoter a perpetual and non-exclusive licence to use such footage and photographs in all media worldwide and the winner will not be entitled to any fee for such use.
- 4.6 The Winners agree they will not sell or otherwise provide their story and/or photographs to any media or organisation other than Seven.
- 4.7 It is a condition of accepting a Prize that the Winner must comply with all the conditions of use of the Prize and the Promoter's, and the Sponsor's requirements.
- 4.8 In the event that an element of the Prize outlined in clause 4.2 is for any reason cancelled, postponed, or not available, that element of the Prize will be considered as forfeited and no cash alternative offer will be granted in lieu of the part of the Prize.
- 4.9 Winners will be contacted by Ansible Pty Ltd on behalf of Seven within 2 business days of their entry being drawn as a Winner, via e-mail and/or phone call to notify them of their Prize and provide Prize details.
- 4.10 Winners must deal directly with Ansible Pty Ltd as distributor of the Prizes. Prize fulfilment will be conducted within five (5) business days following the winners' acceptance of the prize. Winners must redeem their Prize (that is both claim and use tickets) within eighty-nine (89) days of the link being sent to them by Ansible Pty Limited via email.
- 4.11 The Winner will be required to provide valid identification to the Promoter or Ansible Pty Limited upon its request. Failure to do so will result in the forfeiture of the Prize at the Promoter's sole discretion.

- 4.13 The Promoter may vary these Terms and Conditions at its discretion, subject to state government legislation

## **5. HOW TO WIN**

- 5.1 There will be fifty (50) Winners drawn from the pool of online entrants on **Monday 26 September 2022 at 10:00 AEST**, who will each win the Prize detailed in clause 4.2.
- 5.2 This is a game of chance and skill plays no part in determining Winners.
- 5.3 Each entrant who has entered the Competition in accordance with these Terms and Conditions during the Competition Period and provided the relevant Codeword within the correct period they entered in ("Qualifying Entrant") will be entered into the Prize Draw. For clarity, entrants must use the correct Codeword provided each day between 4.00pm and 6.00pm during the 7NEWS live stream on 7plus throughout the Competition Period to be considered a valid entry. Entries that do not comply with any of the Terms and Conditions, may be deemed invalid and a re-draw will be conducted in its place. The prize draw will take place at Ansible Pty Ltd, Level 3, 100 Chalmers Street, Surry Hills NSW 2010.
- 5.4 The Winners will be notified by email and/or phone call from Ansible Pty Ltd within two (2) business days of the prize draw. The Winners will be published on the 7NEWS website within five (5) working days of the prize draw.
- 5.5 The Promoter's decision is final and the Promoter will not enter into correspondence regarding the result.
- 5.6 The Promoter may in its absolute discretion deem entries invalid subsequently to a Winner being notified or a Winner's name being announced if it is discovered that the Winner did not enter the

Competition in accordance with these Terms and Conditions. In these circumstances, an additional draw will be conducted, and a new Winner awarded the Prize.

- 6.3 Seven Network (Operations) Limited, Sydney Zoo Pty Ltd and its associated agencies and companies will not be liable for any misadventure, accident, injury, loss (including but not limited to consequential loss) or claim that may occur:
