Terms and Conditions

By entering “South Aussie with Cosi: AFL Gather Round Competition” (“the Competition”), you are agreeing to the following Terms and Conditions:

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

2.1 Subject to clause 2.2, entry is open to all residents of South Australia aged 18 years of age or older, where the Channel Seven (and affiliates) signal is received.

2.2 Employees and their immediate friends and families of the Seven Network (Operations) Limited (the “Promoter”), Ansible Pty Ltd, their associated agencies and companies are not eligible to enter.

2.3 If the Winner is unable to complete the travel to Adelaide between **Wednesday 12th April to Sunday 16th April 2023** they will forfeit the prize in full and a re-judging will take place as specified in these terms and conditions.

3. HOW TO ENTER

3.1 The Competition **Sunday 19th March 2023 at 06:00 ACDT** and concludes on **Sunday 2nd April 2023 at 23:59 ACST** (“the Competition Period”).

3.2 **COMPETITION ENTRY:** In order to enter the Competition, viewers must:

2. Head directly to 7news.com.au/gatherround; and
3. Complete all required fields in the competition entry form and answer the question ‘in 25 words or less, which 2 friends from interstate would you want to come to experience the AFL in Adelaide and why?’ to submit their entry

3.3 Entries that meet the requirements of clauses 3.2 and adhere to these Terms and Conditions will be deemed a valid entry (“Valid Entry”).

3.4 Entries are limited to one (1) valid entry per person per day throughout the competition period.

- 4.3 Prize Winners will be contacted by Seven Network's competitions partner, Ansible Pty Ltd, on behalf of Seven Network, via e-mail and phone call, to notify them of their prize and provide prize details.
- 4.4 Once the prize is accepted, the Winners must deal directly with Ansible Pty Ltd as distributor of the prize. Ansible Pty Ltd will liaise with the Prize Winners to collect their details and then book their accommodation accordingly.

- 4.7 It is a condition of accepting the prize that the Winners must comply with all the conditions of use of the prize, the Promoter's and Prize Provider's requirements.
- 4.8 In the event that an element of the prize outlined in the above is not available for any reason, the Promoter reserves the right to substitute with a similar product of equal or greater value, subject to state regulations.

- 5.2 Specified accommodation and flights are subject to availability at the time of booking. Alternatives may be offered dependent on availability.
- 5.3 Once confirmed in writing, accommodation dates and names of those staying are not changeable without incurring extra fees. The Promoter and Ansible Pty Ltd do not accept responsibility for any fees incurred as a result of any changes made and these costs will be borne by the Winner and any companions.
- 5.4 The Winner's interstate companions must reside in the same state and complete the travel to Adelaide together.
- 5.5 Flights will be taken on airline/s determined at Promoter's discretion.
- 5.6 Promoter will determine capital city airport flights depart from and return to, at its sole discretion.
- 5.7 The prize is non transferable and cannot be redeemed for cash and cannot be taken in parts.
- 5.8 Air Tickets are available on the regular scheduled services of each airline and are subject to seasonal embargos. Flight itinerary may have to be adjusted depending on the airlines departure city and their current flight schedule. Frequent Flyer points are not available from any airline on the travel prize and the Winners and their travelling companions cannot upgrade any travel prize using Frequent Flyer points. Once airfares are booked and confirmed Winners cannot make changes. It is the responsibility of the Winner and their travelling companions to ensure they have organised any documentation required for the flight component of the prize.

6. HOW TO WIN
