Terms and Conditions

By entering “7NEWS Melbourne AFL Grand Final Giveaway Promotion” (“the Competition”), you are agreeing to the following Terms and Conditions:

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

- 2.1 Subject to clause 2.2, entry is open to all residents of Victoria aged 18 years of age or older.
- 2.2 Employees and their immediate friends and families of the Seven Network (Operations) Limited (“the Promoter”), Ansible Pty Ltd and their associated agencies and companies are not eligible to enter.
- 2.3 Winners (“Winners”) must be available to travel to Melbourne to complete the Prize, arriving on Saturday 30 September 2023 and departing on Sunday 1 October 2023. If a Winner is unable to attend, they will be deemed invalid, forfeit the Prize in its entirety and a re-draw will take place to allocate the Prize to a valid Winner.

3.2 For entry details and the nightly codeword, viewers must be watching 7NEWS Melbourne on weeknights at 18:00 AEST during the Competition Period.

- 3.3 In order to enter the Competition, viewers must:
